Pursuant to Sub-Regulation 3 of Regulation 30 read with clause (8) of para B of Part A of Schedule III of the Listing Regulations, we hereby inform you that InterGlobe Enterprises Private Limited and Mr. Rahul Bhatia, as claimants (the "**IG€ Group**"), have submitted a Request for Arbitration dated October 1, 2019 to the London Court of International Arbitration under the shareholders agreement dated April 23, 2015 (as amended on September 17, 2015) (the "**Shareholders Agreement**") executed between, *inter-alia*, the IG€ Group, Mr. Rakesh Gangwal, The Chinkerpoo Family Trust, Ms. Shobha Gangwal (together with Mr. Gangwal and The Chinkerpoo Family Trust, the "**RG Group**") and InterGlobe Aviation Limited (the "**Company**"). The IG€ Group and the RG Group are promoters of the Company. The Company has been named as a respondent as it is a party to the Shareholders Agreement.
